- Ensure supply of fresh air in closed rooms.
- Avoid contact with skin, eyes, and inhalation.
- Observe protective measures mentioned in paragraphs 7 and 8.

Environmental precautions:

- Prevent spread of product or of bigger quantities of contaminated wash water over a wide area in water and soil.
- Product should not reach the sewerage system.

Methods for cleaning/taking up:
